Next Month: January will be a very busy meeting. Some important issues will be discussed that we must act upon.

1st: The County Board is considering our building at 800 S. Buchanan St. to be designated an Historic District in Arlington. On Dec. 19, the Planning Commission made their recommendation to the County Board. On Jan. 7 the County Board will hold public hearing and make their decision. Harry Gray House and Glebe House are also being considered.

2nd: Arlington County Civic Federation had requested written recommendations from each Civic Asso. concerning the County Board's possible change in Zoning regulations governing "Accessory Dwelling Units".

3rd: The Planning Commission and County Board will be considering a request (U) 2399-83-1 by Hal Kinney for Site Plan approval of a residential cluster development of 8 townhouse units on So. 4th St.

Jan. 21, 1984 - 8:00 A.M. - Court House, Room 202 - County Board.
