## **New BSCL Officers Up For Election in May**

The May BSCL meeting will involve a lot of voting. All BSCL members are eligible to vote at the meeting, which takes place at 7:30 p.m. Thursday, May 1.

First, there will be an election of BSCL Officers and Board of Directors. The slate includes David Michaelson for president; Mark Wigfield for vice president; Gary LeFebvre for treasurer; and Bill Huddleston for corresponding secretary. Michaelson and Wigfield currently serve on the board, in other capacities.

Then the membership will be asked to approve funding for the first phase of the Community House renovation at a cost of about \$55,000.

We will then have an update on the Hi Cue shooting and a discussion of long term strategies on how to address the situation. There will also be a discussion about the status of the Demeter House situation.

## **Project to Include Air Conditioning, Furnace**

After two years of planning, the BSCL renovation committee is ready to move forward with the first major phase of the planned renovation. This will include replacing the furnace in the kitchen with one located in the attic, adding air conditioning, a handicapped accessible bathroom, all new electrical service and wiring, and new walls and floor in the kitchen.

We have obtained multiple quotes from the various trades and plan to coordinate the work ourselves to save money. The cost will be around \$55,000. We hope for less, since a safety margin is included for contingencies. The BSCL currently has about \$69,000 in savings.

In later phases, we plan to make the building handicapped accessible, remove the false ceiling in the main hall to expose the original wood ceiling, install new drywall on the main hall walls, and replace the roof.

## **Homicide at Hi Cue Subject of BSCL Talks**

At the April meeting of the BSCL, Scott Brinitzer's presentation was shortened to allow for discussion about the recent shootings outside the Hi Cue pool hall at the corner of S. George Mason Drive and Columbia Pike.

Lt. Panther of the Arlington County Police informed us that a man was shot in the head and killed just outside the Hi Cue pool hall on Monday, March 23 around 2 a.m. Two nights earlier on Saturday morning around 12:30 a.m. a man was seriously wounded by gun fire at the same location.

After the first shooting the police increased their presence in the parking lot. The second shooting took place during a five minute window when an Arlington police officer was away on a bathroom break. The police were scheduled to maintain a night time presence at the location until April 7. Lt. Panther said that police have temporarily installed a high quality video camera inside Hi Cue. Videos taken the night of the shooting were of very low quality and not useful by the police. The owners of Hi Cue plan to replace their system with a high quality video system.

Andy Lowe, property manager for the shopping center for the last 12 years, was on hand to relate what the property owners' response has been. The property owners are planning to enforce the 2:30 a.m. closing of the Hi Cue per the rental agreement with the owners of the pool

hall. Previously the Hi Cue had been lax about closing and were open well past 2:30 a.m. on weekends.

Second, the property owners will hire an off-duty Arlington Police officer who will be in uniform, with patrol car, and armed. Previously the shopping center owners hired an unarmed security guard who was present the night of the shootings. Third, the lights will remain on all night long instead of being on only during business hours.

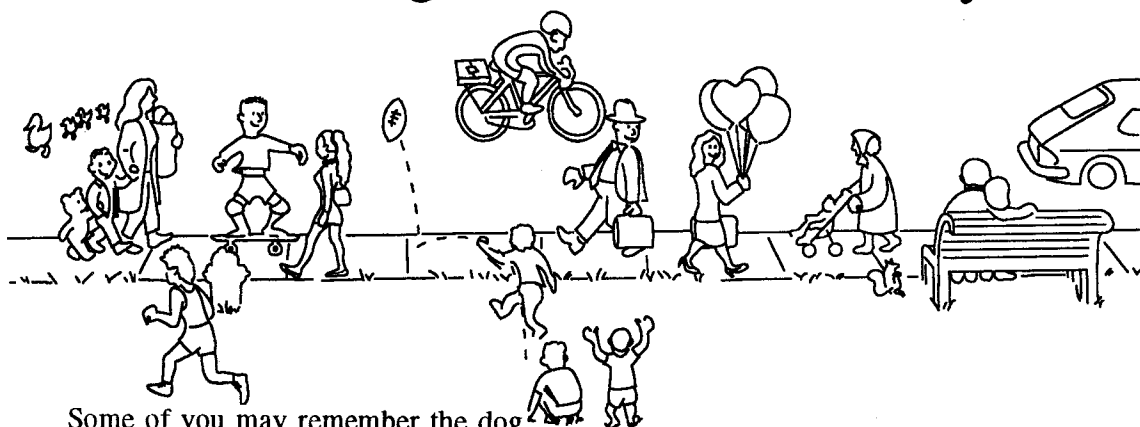
Arlington County Board member Chris Zimmerman was on hand to present the County's actions. Earlier, County Board member Paul Ferguson had asked the County manager to find a way to close the Hi Cue in light of the continuing murders taking place there. Mr. Zimmerman said the manager's report had not been completed but that it did not look like the County could do much. Hi Cue does not operate under Use Permit or have a liquor license which could be revoked.

## **Hi Cue Shootings: Deja Vu, All Over Again**

Four years ago, in March 1993, we wrote in the News: "In response to continuing Barcroft community concerns about crime in the neighborhood, the February BSCL meeting again focused on the subject of crime. The area of primary concern was the 900 block of South George Mason Drive, particularly in and around the shopping center and the Hi Cue Billiard Hall..

Mildred Handy passed away in 1986 but her work lives on. Thank you to Mrs. Robertson for printing the booklet and to Betty Handy for helping with all of these efforts. The Handys and Mrs. Robertson's family, the Maryes, are longtime family friends, going back several generations. Mrs. Robertson, whose family home on S. Wakefield was built in 1892, has traced her family in Virginia as far back as 1730.

## Landscaping Advice Given to Barcrofters

One of our most active BSCL board members, Scott Brinitzer, gave a presentation at our April meeting on the use of landscaping design plans to provide

a framework for improving your lawn.

He demonstrated the technique with three different design concepts for the Community House grounds. In brief, a plan lets you add or move plants while keeping a sense of where you want to go with your yard, with fewer mistakes and replantings. It helps you decide what to do next, or where to put that azalea that Aunt Minnie gave you for Easter or you saw on sale and bought on impulse.

Scott, who lives on 8th Street, planted the perennials you see blooming at the Community House now, and circulated the petition for the new street lights along Buchanan. Call him at 892-0308 if you are interested in upgrading the lights on your street.

being taken by the Arlington County Police Department to reduce the level of crime-related incidents in the 900 block. ... (including) the new "No Trespass Program" being implemented at the shopping center in cooperation with the merchants, including Hi Cue."

That describes our April 1997, meeting almost exactly. The No Trespass Program had just been implemented after four years. Hi Cue's lease was renewed in December for seven more years. A new and important element was a promise by the shopping center that they would hire off-duty Arlington policemen to provide security, which the County is now providing at taxpayers' expense.

The County Board representative was Chris Zimmerman, who lives just blocks from Hi Cue and is as concerned as we are, but did not offer any hope of closing the

business. The most helpful new note was the involvement of the Columbia Pike Revitalization Organization, whose Conchita Mitchell skillfully brought many parties together in a series of productive meetings terminating in a very fine letter laying out what everyone had agreed to.
